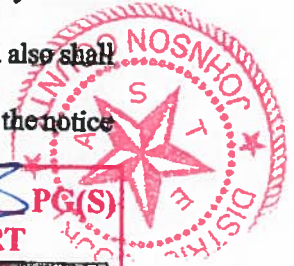

On this day, came on the application of Lilia Dora Salisbury in her capacity as the Presiding Judge of the Election Precinct for the City of Rio Vista, Texas, for the May 4, 2019, municipal election in the above matter.

The Court heard the testimony of Lilia Dora Salisbury, the Presiding Judge of the Election Precinct for the City of Rio Vista, Texas for the May 4, 2019, municipal election. And the Court, having heard the same and having considered the matter presented, finds that the application of the Presiding Judge of the Election Precinct for the City of Rio Vista, Texas for the May 4, 2019, municipal election should be GRANTED.

It is therefore Ordered that a true copy of the signed Notice be posted of the date, hour, and place for opening and the breaking of the seal on the Ballot Box #3 and Ballot Box #4 for Election Precinct for the City of Rio Vista, Texas. Said notice shall be posted continuously for the 24 hours immediately preceding the hour set for the opening Ballot Box #3 and Ballot Box #4 and the breaking of the seal on the bulletin board used for posting of meeting of the governing body located at 201 TX-174, Rio Vista, TX 76093 (this posting shall be available 24 hours a day) and also shall be posted on the City of Rio Vista website; that a good-faith attempt to continuously post the notice

on the website during the prescribed 24 hour period shall comply with the internet posting requirement of this order.

It is further Ordered that, at the appointed time, 5:00 o'clock P.M., Tuesday, May 14, 2019, the Presiding Judge of the Election Precinct for the City of Rio Vista, Texas or her designee shall open the Ballot Box #3 and Ballot Box #4 from the May 4, 2019, municipal election, one of which contain order to retrieve the **stamped early voting and election day voting rolls** which were erroneously placed in the one of the ballot boxes containing the voted ballots and other records relating to ballots voted on May 4, 2019, City of Rio Vista, Texas municipal elections.

The **stamped early voting and election day voting rolls** which were erroneously placed in the one of the ballot boxes that were required to be delivered to Patty Bourgeois, the Johnson County Elections Administrator pursuant to §66.051(d) of the Texas Election Code.

Upon removal of the documents required to be delivered to the Johnson County Elections Administrator, the seals on the Ballot Box #3 and Ballot Box #4 shall replaced at with new seals with the number of the seals being recorded as required by law.

It is further Ordered that Lilia Dora Salisbury in her capacity as the Presiding Judge of the Election Precinct for the City of Rio Vista, Texas, for the May 4, 2019, municipal election shall within 24 hours submit the **stamped early voting and election day voting rolls** to Patty Bourgeois, the Johnson County Elections Administrator or her designee pursuant to §66.051(d) of the Texas Election Code.


Any interested person may observe the opening of Ballot Box #3 and Ballot Box #4 and the breaking of the seal.


